- 1. Quotation once offered shall not be withdrawn by Service provider/Contractor.

- 3. The rates quoted must include all taxes, duties/levies, GST (Goods and Service Taxes) freight, insurance, transportation, delivery, and loading unloading of required material if any at the site etc.
- 4. OEM of existing system can participate and authorized Service provider/ Dealer can participate through its authorization letter from OEM. Service provider / Dealer has to quote comprehensive rates for items mentioned in above table, fault/malfunctioning arise in any of them or in whole EPABX SYSTEM shall be replace/ repair by Service provider/ Dealer within quoted rates (except damage caused power fluctuation or physical impact).
- 5. Right to accept any or to reject any or all the Quotation or reduced the scope of work without assigning any reason thereof is reserved by the competent authority of Surat Municipal Corporation, Surat.
- 6. Quotation to whom the award is made must enter into agreement and other formalities on Stamp Paper as per latest Gov. Rules. Expenditure shall be borne by the contractor.
- 7. 02% SD (Security Deposit) of total contract value shall be submitted in form of D.D. by contractor within 15 days after awarding the contract. Failure to this tends to SD delay penalty 0.065% of SD amount per day.
- 8. While Calculating total amount, Service period to be taken into consideration will be the Service period executed by work order.
- 9. The Service provider/Contractor must keep available their technician at SMC Head Quarter, Muglisara, Surat on daily basis.

- 10. Firm who have not registered party code in SMC, may also apply for the said work subjected they have to generate the party code of the payment purpose by submitting required documents.
- 11. Quotations received after due date will not be considered.
- 12. Quotations sent by post or courier of services or in person is preferable.
