Scope of work :-

1. It is presumed that the offer is given after site inspection and keeping in view the scope of work. Site visit should be done and necessary technical specification/information should be collected before quoting the rates. No dispute at later date shall be entertained.



2. Quotation once offered shall not be withdrawn, except with the permission of the competent authority. Quotation once accepted shall be binding to the contractor.
3. Rate must be filled in this quotation paper only and returned duly sealed & signed otherwise offer will be rejected. No escalation in price during the contract period shall be allowed.
4. The bidder must attach GST registration certificate, PAN Card etc. The contractor shall have an active experience in SETC of sewage submersible pump set in any government organization. He must submit necessary evidence viz. work order/work completion certificate etc. for the same.
5. The rates to be mentioned in Annexure should be inclusive of all duties, GST & any other govt. levies if any.
6. Sewage submersible pump brands should be of Leo, Flowchem, Grundfos, Wilo(Mather & Platt) Aqua, Kirloskar, Pullen, ABS, KSB, Worthington(WPIL), Beacon Weir, Jyoti, Flowmore & must have minimum 1 year manufacturer warranty from date of supply.
7. SMC will not pay any transportation charges & all accessories/spares required for setc of sewage submersible pump set in annexure are in contractor's scope. Contractor must install submersible pump set along with genuine spares only.
8. Successful bidder have to entering into contract agreement and furnishing undertaking to SMC supported by surety from local reputed contractor to be given on suitable Indian Non Judicial stamp paper worth Rs. 300 each purchased from Surat. However, the stamp duty at prevailing rate shall be applicable if revised by Government.
9. The decision of Dy. Commissionershree shall be final in respect of disputes what so ever arise. Corporation reserve the right to accept or reject any or all the quotation without assigning any reason therefore.
10. In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that will be maximum up to 10% of delayed work.
11. The offer shall remain valid up to 120 days from the date of receipt of the quotation. Time limit for the work will be 30 days.
12. The name of work i.e."Quotation for SETC of..... "must be mentioned on the envelope without which quotation is likely to be rejected, which must be noted.
13. Any dispute will be subject to the court, falling under Surat jurisdiction.
14. Contractor shall be responsible to the accident/injury/Loss to any of the staff members of them. No compensation of any kind shall be paid by the corporation. The contractor shall observe latest Government rules regarding labour etc.
15. Successful Contractor shall be required to deposit an amount equal to 2% of total order value as Security Deposit in Cash/ by Demand Draft within 10 (Ten) days from date of work order, otherwise penalty @ 0.065% of the Security deposit Amount per day of delay shall be charged.
16. Payment will be release after completion of work as per actual work done at site.
