- 3. Contractor has to quote rate per unit only and multiple with total quantity.
- 4. The rates include removing of existing tube lights from bus shelters, Supply, Installation, and Testing& Commissioning of LED Light Fixtures. Nonfunctional tube lights not to be submitted to authority and functional tube lights to be installed at other bus shelters to be decided later on. Contractor has to provide warranty (Entire fitting) of 01 year.

- 5. No Advance Payment will be given. 95 % Payment will be given after successful completion of work of SITC and 05 % Payment will be released after 06 months subject to satisfactory work.
- 6. Delaying in submission of the quotation will not be considered.
- 7. Contractor must follow technical specifications as mentioned, submission of warranty certificates and bill /challan.
- 8. Selected products must be in existence since last 03 years (at least 03 years older) and hence contractor has to mention Brand and product name (with product number) along with its LM 79 and LM 80 certificates
- 9. Surat Sitilink Ltd has right to change quantity in ± 30 % of quantity. It may reduce or offer order for more quantity on the basis of approved rate in the future.
- 10. Surat Sitilink Ltd Reserves the right to accept or reject any or all the quotations received without assigning any reasons thereof.
