- Work is to be carried out for Supply Installation Testing and Commissioning of Sine wave Inverter with batteries (Including 2 Years of maintenance) at Saniya Hemad Urban Health Centers of Surat Municipal Corporation. Inverter system is to be used to provide back up power supply for deep freezer in case of failure of power supply from Service providers. Inverter is kind of interactive type. Deep Freezer can be used to store vaccinations at Hospitals/Health centers of Surat Municipal Corporation. Inverter and batteries must be erected/installed on appropriate size trolley. One Unit of Inverter system includes One No. of 1.5 KVA(Min.) Sine wave inverter, Two Nos. of 12V/200 AH Lead Acid Low maintenance tubular batteries and Trolley.
- The above mentioned unit has two year of Defect Liability Period. Bidder has to maintain inverter unit with batteries for 2 years from the date of successful commissioning of the unit at different locations of SMC. In Defect Liability Period (i.e 2 years from the commissioning of the system) bidder has to check quarterly performance of the inverter unit with batteries. Bidder has to attend any complain regarding any component failure or non-function of the inverter unit including batteries within 2 hours. If any component is non-repairable within 2 hours, bidder has to arrange temporary back up system. In any case back up power supply must be in working condition for 2 years. No relaxation is allowed in this regard.
- **The quoted price shall include all taxes (including GST), duties, levies, overheads, insurance, transportation, freight, construction cess etc. whatsoever is applicable and the price shall remain firm till the completion of the project in all respect.**
- **BREACH OF WARRANTY :** In the event of a breach of warranty, the contractor shall be required to take all necessary action at his cost and expense to correct the breach in the most expeditious manner dictated by the existing circumstances. Upon oral or written notification of defects or malfunctioning of equipment during normal operation, which requires corrective action, the Contractor shall send the necessary personnel with the required materials, tools, test equipment and such other items to site to supervise and assume responsibility for repair. If the Contractor does not expeditiously take steps to correct the defects, the Engineer-in-Charge may at its option do so. However, such action on the Engineer-in-Charge's part, will not release the Contractor of his responsibility and the Contractor inter-alia shall reimburse all the expenses incurred by the Engineer-in-Charge to repair or replace malfunctioning or non- conforming equipment.
- **MAINTENANCE AND DEFECTS AFTER SALES SERVICE**
  - ✓ The Contractor shall ensure that adequate and prompt after sales service in the form of maintenance personnel and spares as and when required with a view to minimize the breakdown period. Particular attention shall be given to ensure that all spares are easily available during the normal life of the equipment.
  - ✓ Defect liability period will be 24 months from the date of satisfactory commissioning. Bidder has to perform all inclusive maintenance of entire inverter system for two years during Defect liability period. After completion of defect liability period of two years, entire system shall be handed over to O & M Contractor/SMC officials of the respective Zone/ Sub Zone. However, spares/ components of the inverter system under the defect liability period shall be provided by the contractor, who has installed the system. Therefore, the rates must be quoted accordingly and no dispute will be entertained at later date.
  - ✓ The material/ equipment offered by the bidders must carry an un-conditional guarantee of **minimum two year from date of commissioning.** The amount of performance guarantee shall be retained till expiry of satisfactory guarantee period. During the defect liability period, all necessary spare(s)/ material(s) required will be supplied/ arranged by contractor

- The contractor should have local office in Surat to give regular service and have to co-ordinate the repairing of entire system according to department's requirement and convenience.
- Spare parts used for repairs shall be original genuine and of good quality and/or same/equivalent as defective/Damage material to be replaced. No second hand material will be tolerated for replacement purpose.
- The contractor will not be provided any transportation fare or other charges if a question arises of transfer of any machine under contract outside the campus for repair.
- The work shall be carried out by certified technicians only.
- Technicians employed for the said work shall be provided with personal safety equipments / accessories.
- Contractor shall be responsible to the accident/injury/Loss to any of the staff members of them. Contractor shall have to make necessary insurance policy and work man compensation policy etc.
- All the Acts Rules and Regulation applicable for such type of work shall be followed by contractor.
- It shall contractor responsibility to get acquainted type of acts rules, regulations, and general rules, Procedure of corporation.
- The Contractor shall quote the rate in "price schedule" only.
- All tools, tackles, labour and material including consumable etc required will be in scope of contractor.
- The bidder must visit the site and get acquainted with site situations before quoting the price. No dispute at later date shall be entertained.

#### 1. TIME LIMIT / WORK COMPLETION PERIOD

- Time limit for the entire job will be 30 (Thirty ) Days.

#### 3. SECURITY DEPOSIT/AGREEMENT/STAMP DUTY:

- The successful Contractor shall be required to deposit an amount equal to **2% of the total order value as Security Deposit in Municipal Treasury** in Cash/ by Demand Draft within 10 (Ten) days of order failing which penalty @ 0.065% of the Security Amount per day of delay shall be charged.
- The successful contractor shall also be required to enter into contract agreement along with undertaking and local surety on Gujarat Stamp Paper purchased from Surat worth Rs.900.00 (i.e. 300.00 + 300.00 + 300.00 for each) (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.

#### 4. PRICES AND TERMS OF PAYMENTS: -

- All rates should be quoted including GST.
- Payment shall be realised 100% of equipment(s) quoted value after satisfactory completion of whole work in all respects.
- Security Deposit shall be realised after satisfactory completion of Guarantee/Warranty/Defect liability period.

#### 5. Penalty Criteria:-

- The work must be completed in all respect within stipulated time period as mentioned in Important instruction to bidder, failing which penalty @ 0.2% of order value of unexecuted portion per day of delay subject to maximum 10% of order value shall be charged and shall be deducted from the bill or any outstanding payment. Also, if contractor fails to execute the work than action against contractor will be taken as per decision of competent authority of SMC and that should bind to contractor
- If, contractor fails to supply required spares of any component within two days of intimation then, following penalty shall be charged and recovered from his pending bills/ security deposit or from any other pending amount / any other works in SMC. (However till date Contractor has to arrange temporary back up system within 2 hours for smooth functioning of Vaccination freezer.) After two days, Per Day penalty shall be considered as 500 Rs.
