- If the tenderer finds any deviation or anomaly, he shall intimate the same to the owner in writing.
- The Tenderer shall submit his tender in sealed cover with the name of the Work written on the outside of all the envelope as under:
- The successful tenderer shall execute the Contract Agreement within fifteen days after the date of Notice of award.
- The successful Tenderer will be required to furnish a performance bond (Security Deposit) of an amount equal to (2%) Two percent of the tendered amount.
- All the applicant contractors are required to have their own employer's code number under EPF Act, 1952 and are required to comply with the applicable provisions of said statute regularly and totally.
- **Time limit** for the entire job will be **06 month** & it will be considered after 10 days from date of the work order issued from date mentioned in the work order.
- Defect Liability Period is **01 Years after Completion of Work**.
- It should be strictly noted that, even if the Defect Liability Period is over, 2% Security Deposit will be released only after Completion of all Audit Related Queries and Procedure and rectification of Defects if any found so.
- Quotation once offered shall not be withdrawn except with permission of the competent authority.
- Quotation once accepted shall be binding to the contractor.
- Conditional Quotations are straight away subject to rejection.
- All duties/ taxes/ GST levied by S.M.C. and Govt. shall be payable by the contractor.
- The rate quoted by the agency should be inclusive of all taxes, Service charges and GST.
