- Planning of fire hydrant along with Sprinkler system and conventional fire alarm system should be as per Norms adopted by Fire department of SMC, Confirming to state and National Building Code (fire safety code) and Supply, Erection, Testing and commissioning (SETC) of the same after design approval from fire department of SMC.
