Inspect/test the soft starter after repairing and than transportation and loading, unloading it again to Godadra Water Distribution Station. Testing and satisfactory working of soft stater at site in scope of Contractor.</li><li>3. Transportation should be in your scope.</li></ol> <p><b>Note :- Contractor has to visit the site and understand the work to quote the rate.</b></p>

Payment condition :-	100% Bill will be Paid after completion of work & Submission of invoice. All applicable taxes and cess will be deducted from this bill as per prevailing norms.

1. Successful agency shall enter into contract agreement on suitable Gujarat stamp paper and depositing an amount equal to 2.5 % of order value as security deposit in municipal treasury in the form of cash/Demand Draft/pay order of any Nationalized/ Scheduled bank of Surat branch and drawn in favor of Municipal commissioner, Surat municipal corporation within 15 days from the date of work order otherwise, penalty @ 0.065% of the amount of security deposit per day of delay shall be levied. Following formalities should be completed within 15 days. The successful Contractor has to submit three number of Non judicial e-stamping/franking paper of Government of Gujarat each of Rs.300/- for agreement, surety and undertaking respectively
2. The performance guarantee (Security Deposit) will be returned to the contractor after the **defect liability period (Six month)** after completion of work) and on completion of audit related procedure.
3. **Time Limit for whole work will be 30 Days from the date of work order.** In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that will be maximum up to 10% of delayed work.
4. The rate should be inclusive of all taxes, duties, and labor charges and transportation but excluding GST etc.
5. The offer shall remain valid up to 120 days from the date of receipt of the quotation.
