3. **Bidder must visit the site before quoting to understand the type and requirement of the work. No dispute of any kind shall be entertained after finalizing quotation.**
4. Time Limit for whole work will be 20 Days from the date of work order. In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that will be maximum up to 10% of delayed work.
5. Successful bidder must have to submit security deposit (SD) of amounting 2.5% of quoted amount, after sanction work in form of Cheque/DD/Pay order only and SD of successful bidder will be released after satisfactorily completion of work.
6. Successful bidder shall have to undergo Agreement, Surety and Undertaking 300 stamp paper each as per SMC prevailing rules within 10 days from the date of work order.
7. Defect liability period shall be 06 month after completion of the work.
