**(B) General terms:**

- (C.1) The mode of submission can be RPAD or Speed Post of Government postal authority or private courier.
- (C.2) This offer must contain EMD in form of a DD/Pay order of Rs.1,900/- issued in favor of "Commissioner, Surat Municipal Corporation" and shall be payable at Surat.
- (C.3) The agency shall fill the rates in this format only. The offer with company profile, qualifying documents, rates, make and model number of offered products, certified catalogs / data sheets of the products, seal and signature on each page along with the original draft of the EMD order shall be sealed in a cover. This sealed cover must contain "name of work, address of the recipient, name and address of the sender and last date of submission of the offer".
- (C.4) The successful agency shall have to submit a security deposit @ a rate of 2% of the order value amount within 15 days from the award of the work order. The DD / pay order shall be issued in similar fashion as mentioned in (C.2) above. A delay penalty at a rate of 0.065% of the SD value per day will be imposed for delayed days.
- (C.5) The successful agency shall have to bind in contract with SMC. The agency shall have to submit three non judicial stamp papers each costing Rs.300/- for agreement, surety and undertaking respectively.
- (C.6) EMD of the disqualified agencies will be returned at least within 15 days after disqualification.
- (C.7) Payment: 100% payment shall be made after completion of the entire work. However, supply of item and ETC will be considered 80% and 20% respectively for each item.
- (C.8) Deductions: All the payments and deductions shall be made as per prevailing rules and standard practice of SMC.
- (C.9) The defect liability period for this work shall be 12 months after successful handover of the work to SMC. The agency shall be liable to resolve any problem within this defect liability period which includes attending the complaint, necessary repair or replacement of any or all components etc.
