Remittance of GST within stipulated period shall be the sole responsibility of the successful contractor/ Bidder, failing which SMC may recover the amount due, from any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the contractor/ successful Bidder in this regard. Further, the non-payment of GST to the government may lead to the termination of contract.

If imposition of any other new taxes/ Duties/ levies/ Cess or any other incidentals etc. or any increase in the existing taxes/ Duties/ Levies/ Cess or any other incidentals etc. (Excluding GST) are imposed during the course of the contract, the same shall be borne by the successful contractor/Biderer only; in no case SMC shall be liable for the same.

# SCOPE OF WORK

- 1. HT Substation and LT Panel equipments are installed at Main Office of Surat Municipal Corporation.
- 2. Maintenance and repairing work of includes General breakdown and Preventive Maintenance of HT Substation and LT Panel equipments of the Muglisarai Main offices as given in Price Schedule as and when required by SMC.
- 3. Breakdown Maintenance must be attended within half hour after intimation from this office.

Preventive Maintenace includes complete cleaning, replacement of damaged gasket, Filtration of Transformer oil and Carrying routine maintenance, servicing and testing of 630 Amp. HT VCB, Carrying routine maintenance, servicing and testing up to 2000 Amp. LT ACB, Carrying routine maintenance and servicing of cubical panel board as maintain in Price Schedule.

- 4. Report for Testing of Transformer, VCB, ACB, Panel and Earthing must be submitted after Preventive Maintenance to Light Department of Central Zone.
- 5. The rate should be inclusive of GST, all taxes, duties, labor charges, transportation etc.
- 6. Price quoted shell be frim for 02 (Two) years any deviation in quoted rate, terms and condition shall not be entertained later.
- 7. Rates must be filled in this quotation paper only and returned duly sealed & signed.
- 8. Planned shutdown shell be arrenged by SMC during that time work must be completed as per instruction of Engineer Incharge of SMC. If contractor fails to complete above work than penalty @ 0.2% of amount unexecuted work per day delayed should be recovered from your bill. Maximum delay penalty shall be recovered 10% of unexecuted amount of work order. Generally, planned shutdown shall be taken on Saturday, Sunday or Holiday.
- 9. Only licensed and permit holder persons must be employed for this work. The corporation will not be responsible for any accident or injury to the workman / staff of the contractor.





- 10. The Contractor shall comply with the provisions of the contract and with due care and diligence execute and maintain the works and provide all labour and materials, tools and takers including for assessment and supervision of Maintenace works.
- 11. All works under the contract shall be executed as directed by engineer incharge.
- 12. The Contractor shall be responsible to take all precautions to ensure the safety of the person or property during work. All work shall be carried out in supervision of valid supervisor/competant person of contractor.

## 1. Penalty Criteria :-

In case of Breakdown the fault must be attended within 1 hour from intimation, otherwise penalty at rate of Rs. 500/- per hour shall be levied subject to maximum 10% of Annual AMC value.

### 2. Time Limit/Work Completion Period :-

Time limit will be 02 (Two) years from the date of Work Order issued.

## 3. Experience Required :-

The contractor shall have an experience in similar works i.e Maintenance and repairing work of HT Substation, Equipment and LT Panel, etc. within left 7 years, Necessary work completion certificate shall be submitted in Technical Bid Cover.

## 4. Prices and Payments :-

- All rates should be quoted including GST in separate sealed cover along with technical bid.
- The tenderer must understand clearly that the prices quoted are for the total works i.e. Breakdown and preventive Maintenance and include all costs due to labour, supervisions, transportation, loading unloading watch and ward etc. including GST.

## 5. EMD/Security Deposit/Agreement/Stamp Duty :-

- Each Quotation must be accompanied by a receipt of deposit as Earnest money deposit of the amount mentioned in Table, in the form of crossed Demand Draft/Pay Order of Nationalized/Scheduled Bank acceptable to Corporation drawn in favour of the "Municipal Commissioner, Surat Municipal Corporation" payable at Surat. The earnest money deposit will be refunded to the unsuccessful bidders(s) after the award of work has been finalized.
- The successful Contractor shall be required to deposit an amount equal to 2% of the total order value as Security Deposit in Municipal Treasury in Cash/ by Demand Draft within 15 (Fifteen) days of order failing which penalty @ 0.065% of the Security Amount per day of delay shall be charged.
- The successful contractor shall also be required to enter into contract agreement along with undertaking and local surety on Gujarat Stamp Paper purchased from Surat worth Rs.900.00 (i.e. 300.00 + 300.00 + 300.00 for each) (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.

### 6. Terms of Payments :-

- No payment shall be made in advance.
- 80% Amount of work executed will be released within 30 Days after from date of completion of Preventive Maintenace & Submission of Invoice.
- Rest pending Amount will realsed after completion one year.

### 7. General Terms & condition:-

1. Corporation reserves the right to accept or reject any or all the quotations without assigning any reason thereof.





- 2. Site visit should be done and necessary technical specification/information should be collected before quoting the rates. No dispute at later date shall be entertained. The bidder can do site visit from 10.30 to 18.10 hrs. During working days.
- 3. The offer shall be reached in a sealed cover to "Executive Engineer, Central Zone, Surat Municipal Corporation, New Admin Building, Mugalsarai, Surat 395 003".
- 4. The rates quoted shall remain in force for full period of contract.
- 5. Corporation will not issue any 'C' or 'D' form.
- 6. The Contractor shall comply with the provisions of the contract and with due care and diligence execute and maintain the works and provide all labour and materials and tools for Maintenace works.
- 7. If, the corporation considers that the performance of the contractor is unsatisfactory or, not up to the expected standard, the corporation shall, notify the contractor in writing and specify in detail the cause of dissatisfaction. The corporation shall have the option to terminate this contract if, the contractor fails to comply with the requisition contained in the said written notice issued by the corporation to the contractor within 15 (Fifteen) days of the receipt thereof. Competent authority may decide, in case of unsatisfactory performance, to terminate this contract and to black list & to disallow this contractor in future tendering in SMC forfeiting the security deposit furnished towards the performance guarantee.

#### Technical Bid & Price Bid :-

- 1. Rates must be filled in this quotation paper only and returned duly sealed & signed.
- The name of work i.e. "Quotation for Preventive Maintenance and Repairing work of HT Substation and LT Panel equipments in Central Zone on Annual Rate Contract basis for 02 (Two) Years." must be mentioned on the envelope without which quotation is likely to be rejected, which must be noted.
- 3. Contractor must have to submit the Quotation with two separate covers. In Cover-I Technical parts of Quotation papers, EMD receipt, Experience documents, technical documents is to be attached and in Cover-II only Price Schedule is to be attached and also note that these both cover must be submitted in Cover-III which is to be mentioned the Name of Work on the Envelope.
- While opening of quotation, Technical Bid shall be opened first, after evaluating technical bid document, Price bid of technically qualified contractor shall be opened only.
