• Specification for Repair Work.

- **1.** In case of breakdown of the Vehicle/Machineries, During Operation, the Contractor is required to provide on the spot facility for its spot repair.
- 2. All old/replaced spare parts shall be the property of the Surat Municipal Corporation and the bidder have to return the same to this municipal workshop.
- 3. The contract will be effective for a period of 12 months from the date of the main work order issued by municipal workshop.
- 4. During repairing work of SMC Vehicle/Machineries any loss, injury or damage resulting from death or personal injury caused by the bidder's negligence, Surat municipal corporation not responsible for loss or any other consequential loss.
- 5. Surat Municipal Corporation has the right to terminate or extend the tender/agreement in whole/in part at any time without assigning any reason therefore. Any decision in this regard taken by the competent authority in the Surat Municipal Corporation.
- 6. In case, the contracting firm is not able to accept the contract after it is awarded or if it is not able to do the work after accepting the contract, it will be liable to pay the damages to the department including the extra rate which this Municipal Workshop will have to pay to any other contractor for getting such work done.
- 7. The contractor shall follow the all type standard safety practice during execution of work.
- 8. The contractor shall deploy skilled labor for at municipal workshop, Umarwada for repairing work as per engineer-in charge whenever called for service.
- 9. The number of manpower required and the specific work assignments will be communicated to the contractor on a case-by-case basis, as per the requirements of SMC.
- 10. All manpower must be trained and skilled in their respective fields and should have proper tools and equipment to perform their tasks efficiently.

11. SMC reserves the right to reject any manpower if found unsuitable, unqualified, or not meeting the required standards.

12. The payments will be made based on actual services rendered, as per the work order and attendance sheets, after necessary deductions (if any), within 30 days from the date of

receipt of the invoice.

13. The contractor shall comply with all applicable labor laws, safety standards, and

regulations as per the Government of India and local authority requirements.

14. If the deployed manpower is found to be unqualified or incapable of performing the tasks, the contractor will be required to replace them at no extra cost to SMC.

Qualification of Manpower

15. The day hour shall be 8 hours per day with the schedule to be determined by the Surat

municipal corporation.

The contractor must ensure that all manpower provided meets the following qualifications:

• Painter: Minimum 2 years of experience in relevant field with knowledge of different

painting techniques, surface preparation, and safety protocols.

• Fitter: Minimum 2 years of experience with Vehicle/Machineries works, knowledge of

repair standards, and safety guidelines.

• Welder: Minimum 2 years of experience in welding, with knowledge of different

welding methods, and safety regulations.

The name of work i.e "Supply of skilled Man-power as and when required for Surat

Municipal Corporation" must be mentioned on the envelope without which quotation is
