- (1) The agency must visit the site before quoting the Rates.
- (2) Quotation once offered shall not be withdrawn by Vendor.
- (3) Quotation once accepted shall be binding to the Vendor/Contractor.
- (4) The rates quoted must be Exclusive GST & include all other taxes, duties/ levies, freight, insurance, transportation, delivery and Loading unloading at the site etc Complete.
- (5) The decision of Deputy Commissioner shri, Public Infrastructure Cell, SMC shall be final in respect of disputes what so ever arise.
- (6) Right to accept any or to reject any or all the offers without assigning any reason thereof is reserved by the competent authority of Surat Municipal Corporation. Surat.
- (7) All necessary safety measures and precautions (including those laid down in the various relevant Indian Standards) shall be taken to ensure the safety of men, materials and machinery on the works as also of the work itself.
- (8) Overall lowest bidder shall be taken for consideration.
- (9) Conditional offer shall not be accepted.
- (10) The contract shall be constituted according to and subject to laws in India and state of Gujarat and under the jurisdiction of courts of Gujarat at Surat City only.
- (11) **An EMD of Rs.5,000/- in form of DD or Pay Order issued in favour of 'Commissioner, Surat Municipal Corporation' and payable at Surat must accompany this quotation.**
- (12) Payment terms :
No advance payment shall be made to contractor
70% of total amount shall be payable after supply of material at site.
20% of total amount shall be payable after installation
5% of total amount shall be payable after testing and commissioning
5% of total amount shall be paid in final bill
7% from each bill shall be kept as retention and shall be paid in final bill
- (13) work delay penalty should be applicable at 0.2% of unexecuted WORK amount per day of delay subject to maximum of 10% of the total work order amount.
- (14) **The successful bidder shall have to submit security deposit at rate of 2 % of the awarded value within 15 days from the date of the work order. Failing of submitting security deposit within 15 days shall lead to a delay penalty at a rate of 0.065% of SD value per day.**
- (15) **The successful bidder shall have to bind in agreement with Surat Municipal Corporation. Bidder shall have to submit 3 non judicial stamp papers each costing Rs.300/- for agreement, surety and undertaking respectively.**
- (16) **Time limit of the work is 45 days after 15days from the issuing date of the work order.**
- (17) **Bidder shall have to write " ONLINE QUOTATION ", mention name of work, name and address of agency/contractor on sealed envelope & submit on or before Dt. 08/04/2025 to CHIEF ACCOUNTANT, SURAT MUNICIPAL CORPORATION, MUGLISARA, SURAT – 395 003 BY R.P.A.D/Speed post Only.**
- (18) All the pages of this quotation shall be signed and stamped by the bidding agency.
- (19) Only power supply provide by SMC.
- (20) Defect liability period should be started after handing over the entire system to SMC.
- (21) The Contractor has to provide o3 services per year during the entire Defect liability period Without any cost.
- (22) The contractor will be responsible to clear the breakdown calls regarding the system. Each breakdown call shall be attended within 04 hours from the intimation through letter, email, SMS, What's app/text messages, telephone call or any other mode. After 04 hours Rs. 20/- per hour penalty will be applicable. in case of hardware replacement under Defect liability period, replacement should be done within 48 hrs, after that Rs. 1000/- per day penalty will be applicable.
- (23) SMC will not be responsible for any accident, injury or even death of the employee of the contractor and no compensation shall be paid in such cases.
- (24) No extra payment apart than the quoted rates shall be made to the contractor during entire work except physical damage.
- (25) Contractor should have to submit employee provident fund registration with this quotation.
