## **TERMS & CONDITIONS:**

- 1. Quotation once offered shall not be withdrawn by Vendor.
- 2. Quotation once accepted shall be binding to the Vendor/Contractor.
- 3. The rates quoted must include all taxes, duties/levies, GST (Goods and Service Taxes) freight, insurance, transportation, delivery, and loading unloading at the site etc.
- 4. Payment will be made after successful completion of work, and it may take at least 1- month time to complete the process of Payment subject to fulfillment of entire document related criteria required by the Account/ Audit department of SMC.
- 5. Firm who have not registered party code in SMC, may also apply for the said work subjected they have to generate the party code of the payment purpose by submitting required documents.
- 6. Quotation received after due date will not be considered.
- 7. Quotation sent by post or courier of services or in person is preferable.
- 8. The contractor will submit the invoice to the SMC having GSTIN of SMC mentioned therein and the taxes shall be shown separately on the face of the invoice to claim as ITC by SMC.

## **ANNEXURE - A**

## **TECHNICAL SPECIFICATIONS FOR AMC OF 70M Hydraulic Platform**

## 1. SCOPE OF WORK

Scope of work includes "Annual Non-Comprehensive Service Maintenance Contract for Five years for Bronto Skylift make Aerial Ladder Platforms (ALP) / Hydraulic Platform (HP) available with Surat Fire Brigade" as per manufacture's service protocol.

- 2. The servicing of Aerial Ladder Platforms (ALP) / Hydraulic Platform (HP) superstructure of Bronto Skylift make, Finland available with Surat Fire Brigade shall be carried out for quarterly checking as per manufacturer M/s. Bronto Skylift and maintenance of each Aerial Ladder Platform and Hydraulic Platform chassis as per respective manufacturer's service schedule.
- 3. The servicing and repairing of the superstructure shall be carried out in Fire Brigade workshop or in the workshop of tenderer as required.
- 4. The service to be provided under the service agreement shall be only such as are on account of normal wear and tear of the unit leading to operational faults. The contractor shall immediately inform SMC representative, if any spare part is required while carrying out the Maintenance work for the smooth operation of the unit. The parts so needed for the smooth running of the ALP/HP shall be replaced after receiving the confirmation from the SMC. Further such services shall be in accordance with the service interval mentioned.
- 5. The AMC contract does not include any consumables. The cost of the same or of any spare parts needed to be replaced shall be informed to SMC during the service visit.
- 6. THE AMC contract shall include replacement of the following items once in 5 years of contract at free of cost:
- a) Return Filter
- b) Pressure Filter
- c) Fuse, Prop valve Filter
- d) Limit switch
- e) Greasing for servicing
- f) Nut & Bolts for Turntable
- 7. Checking of the Super structure for corrosion. The charges for the repair in case of corrosion will be on extra chargeable basis depending on the nature of the job with prior approval of SMC.
- 8. Any accidental repair shall not be covered under the contract. The tenderer shall inform and take the written approval of the Chief Fire Officer or its representative about the actual charge of spares parts and labour charges for this repair as per the price list of OEM.
- 9. The consumables used for servicing and repairing shall be brand new and originally sourced from the reputed manufacturer as approved by the ALP and HP manufacturer.
- 10. All components, assemblies, parts removed from the unit and replaced with a new part are properties of the customer.
- 11. Five free visits to attend break-down calls in a year. After five break-down call, further break-down visits to be chargeable.
- 12. Quarterly inspection of the ALP/HP of Bronto Skylift make shall be carried out as per terms and conditions of the contract either by Bronto Skylift Oy AB, Finland Engineer or trained Engineer of Indian agent/dealer/distributor.

- 13. In addition to periodic maintenance, successful Tenderer shall depute Authorized Service Engineer for attending Emergency Breakdown as and when required by Surat Fire Brigade within 72 hrs. from the receipt of the complaint either at respective fire station or at Fire Brigade workshop or place of break down.
- 14. Servicing of the chassis of vehicle shall be carried out by SMC and is not in the scope of the tenderer.
- 15. The rates quoted for the Service Maintenance Contract shall be inclusive of all the cost including any miscellaneous cost. The cost of sending the ALP/HP to the tenderer's workshop, if needed, shall be borne by SMC.
- 16. The servicing and repairing of Aerial Ladder Platform and Hydraulic Platform (Super structure and Chassis) shall be carried out by trained person authorized by the Hydraulic Platform OEM.
