User Manual for Registration & Renewal Process for Online Shops and Establishment

New Registration Procedure:

- 1. For Gumasta Registration, you have to visit in www.suratmunicipal.gov.in.
- 2. Go to Online Services --> Shops & Establishments Certificate --> Shops & Establishments License --> New Registration.
- 3. Create your Account in Surat Municipal Corporation with your Mobile No. and E-mail address and verified it (both verification required).
- 4. Login with your Registered Mobile No. or E-mail address (after verified) and complete your profile.
- 5. Go to Shops & Establishment --> New Registration --> Fill up all details (Establishments & Owner Details) and upload Documents with self attested signature for Registration --> save.
- 6. Shops & Establishment Inspector will approve your application after satisfy with your uploaded documents.
- 7. Once Shops & Establishments Inspector approves your application, you get intimation for payment by sms and Emaild.
- 8. Go to Shops & Establishment --> Check Application Status --> Payment (online Payment within 10 days).
- 9. After Payment done successfully, Shops and Establishment Registration Certificate is issued immediately.
- 10. Go to Shops & Establishments --> My Transaction --> Print Receipt & Certificate or Check your E-mail.

Documents to be submitted:

- 1. Property Tax bill
- 2. Sale and Purchase bills
- 3. Ownership / Occupation proof
- 4. Rent Agreement, if applicable
- 5. Partnership Deed, if applicable
- 6. Registration of co-operative institutes including resolution for President and Committee members, if applicable.
- 7. Articles of Association and / or Memorandum of Association, if applicable
- 8. Copy of Form No.32 in case of change in name of Director of the Company, if applicable.

Time Line for Processing of Application: 30 Days

Renewal Procedure:

- 1. Follow the Steps 1 to 4.
- 2. Go to Shops & Establishment --> Check & Pay Renewal Charges --> Fill up your Shops & Establishment Registration Details --> Payment.
- 3. After Payment successfully done, Shops and Establishment Registration Certificate is issued immediately.
- 4. Go to Shops & Establishment --> My Transaction --> Print Receipt & Certificate.
