WHEREAS under Government Notification, Panchayats, Housing and Urban Development Department, No. GH/P/52 of 1977/TPS/4276/2109-Q dated 20th April, 1977, the Government of Gujarat had, in exercise of the powers conferred by sub-section (2) of section 28 of the Bombay Town Planning Act, 1954 (Dom. Act No. XXVIII of 1955) (hereinafter referred to as "the old Act") sanctioned a draft Town Planning scheme Surat No. 12 (Adajan) (hereinafter referred to as the "the said draft scheme") submitted to it by Surat Municipal Corporation, Surat ;

AND WHEREAS in exercise of the powers conferred by section 31 of the Old Act, Government of Gujarat had appointed the Town Planning officer for the said draft scheme ;

AND WHEREAS the Town Planning officer so appointed has submitted to the Government of Gujarat the Town Planning scheme Surat No. 12 (Adajan) Preliminary scheme (hereinafter referred to as "the said Preliminary scheme") as required under sub-section (2) of section 52 and section 64 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) ;

NOW, THEREFORE, in exercise of the powers conferred by section 65 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) the Government of Gujarat, hereby -

- c) a) sanctions the said " Preliminary scheme " subject
to the modification enumerated in the schedule
appended hereto ;
- b) states that the said scheme shall be kept open
for inspection by the public at the office of the
Surat Municipal corporation, Surat during office
on every day except Sundays and Holidays ; and
- c) fixes the 27th day of March, 1987 as the date
the purposes of clause (b) of sub-section (2) of
said section 65.
